### **MISSION**

The Upper Chama Soil and Water Conservation District promotes stewardship of natural resources by providing leadership, education, technical and cost-sharing assistance to landowners/users with the district.

### **Financial & Technical Assistance Programs**

- The District continued to cost-share in the amount of \$15,000 towards the Northern New Mexico Cooperative Weed Management Area program. The program offers technical, financial and educational assistance in addressing the Invasive weed resource concern. Equipment and cost share assistance is offered to the landowners in order to address *Invasive* Weed Management.
- The District in conjunction with the East Rio Arriba SWCD, sponsored a Noxious Weed
  Meeting at the Abiquiu Event Center inviting local, state, county and federal officials to
  develop a collaborative approach to address our weed infestation.
- Under the District's **CWMA** program:
  - Chairman Norman Vigil, Supervisor Eloy Olivas and Program Manager Kenneth Baca attended monthly CWMA meetings at the Rio Arriba Events Center throughout the fiscal year.
  - Chairman Norman Vigil met with Lucia Sanchez, Rio Arriba County Manager and Napoleon Garcia, Rio Arriba County Public Works Administrator, to educate and engage the County regarding the District's CWMA program.
  - o Program Manager Kenneth Baca attended a CWMA workshop.
  - The District contracted work for spraying in an area along the Colorado border on New Mexico State Trust Land for various thistles, chicory, Russian knapweed, willows and mustard. As of June 30, 2023 approximately 120 acres have been sprayed and another 50+ acres are planned to be sprayed by mid-July.
- The District continued to cost-share with landowners for Water Development Improvements, Forestry Management Practices, Brush Management and Erosion Control through the funding obtained from the SWCC and RCSI RCPP.
- The District has an Equipment/Implement Rental Program for all landowners. The landowner
  provides seed, fuel and general daily maintenance of equipment/implements. The District
  provides the equipment to the landowners for 3 days with a maintenance fee and deposit fee
  which is refundable once equipment is returned. This year over <u>20</u> landowners utilized the
  equipment.
- The District continued to provide Water Management Funding for Acequia Infrastructure Repairs through the established Acequia program. Each request is reviewed and funding is determined according to need. Acequia projects must be a group governed by a board and must contribute in-kind or monetary cost-share. Acequias are also encouraged to apply for funding through NMACD Statewide Acequia RCPP, ISC construction program and NRCS. Individual projects are also considered on irrigation needs. The individual may use the funds provided for materials or technical assistance.
  - The District provided Acequia program guidelines to applicants.
  - The District provided monetary assistance from our Conservation Projects (Acequias) fund to Julian Herrera for Acequia de La Plaza Blanca, Landowner Genevieve Cordova, and Landowner Paul Cordova.

#### Grants

• The District applied for the SWCC Appropriation Funding and was awarded \$750,000. The program, **Building Resiliency in the Upper Rio Chama Watershed**, was initiated in June and the objectives are: a) Restore and build forest resiliency to deal with drought and catastrophic fires as the highest priority with adjacency as a key approach. The high fuel and drought

conditions have posed a health and safety issue for residents within the district and downstream. Hazardous Fuel Reduction will minimize the flooding and erosion impacts during the intense storms, reduce the intensity of wildfire, and reduce the threat of catastrophic wildfires, and b) Implement watershed rehabilitation to provide ecosystems benefits for livestock, wildlife, fisheries, acequias and erosion control. Taking a holistic approach toward watershed management will improve fish and wildlife habitat, water availability for wildlife and livestock, erosion control, and provide for the continuance of our cultural acequias.

- The District is partnering with the NM Water Resources Research Institute on the Canjilon Creek Hydrologic Project funded through the NMED River Stewardship Program; application was submitted and received funding from the SWCC. Connie Maxwell, PhD and the USCSWCD will lead the efforts in this project.
- The District submitted a proposal to the **2023 WTB** but appears that funding was not provided.
- The District submitted a proposal for the **2023 WUI** with the State Forestry but we were unsuccessful.

### **Partnerships**

- Partnership with East Rio Arriba SWCD continues for the Northern New Mexico CWMA
   Program. The District is responsible for the chairmanship and the ERASWCD is the fiscal
   agent. It is the District's desire to keep this partnership active and positive in order to address
   the needs of all landowners with noxious weeds. Both Noxious Weeds Coordinators work
   together to make public the program. Over 300 acres were addressed this year. The program
   was once again approved for a grant this year.
- The partnership with **New Mexico State Forestry** has provided financial and technical assistance to private landowners through the use to NFL funds. The District and NMSF are continuously looking for opportunities to improve and sustain our watersheds.
- The District maintains a Memorandum of Agreement with NRCS. The major assistance available from the District is technical/financial assistance provided by NRCS programs and delivered by their staff. Mr. David Griego, District Conservationist, and staff report at our monthly regular board meetings.
- The partnership with ERASWCD and numerous other agencies, non-profit and organizations continue to provide funding for private landowners and public land leases to implement on ground conservation practices on forest, range, and irrigated lands in northern New Mexico and southern Colorado through the Rio Chama/San Juan RCPP. The District was involved with initiating the NM Acequia Rehabilitation RCPP in 2014 and subsequently totaling \$7.1 million. As a multi-partner the District's role was outreach to encourage and initiate Acequias interested in applying for financial funding and technical assistance. Applications were accepted at the District Office. Two applications were funded within the District and construction initiated in the spring of 2021 and completion was in the fall of 2022.
- The District has been actively involved with the **Carson National Forest** in developing the 10 year forest revision plan. The District attended and participated in the forest revision plan for the Carson National Forest as a cooperating agency.
- Chairman Norman Vigil participated in the **2-3-2 USDA Collaborative Group** (Colorado and New Mexico) in the executive group meetings and working group meetings throughout the year and on a monthly basis.
- The District partnered with East Rio Arriba SWCD and housed college student Estella Gomez, who was hired by East Rio Arriba for their **Youth Conservation Corps (YCC)** summer program.

- The District is a key partner in the RCPP implementation in both Colorado and New Mexico providing input throughout the year.
  - Chairman Norman Vigil had a call with Jefferson City from Colorado about RCPP program in March to share thoughts and lessons learned from New Mexico "alternative funding arrangement" for RCPP.
- The District paid dues to NMACD and NACD during the FY 22-23.
- The District continues its partnership with Chama Peak Land Alliance (CPLA). The District has
  worked closely with this partnership to identify priority areas for forest treatment. CPLA and
  the District have developed a program to provide firewood to seniors and needy families in
  the Chama Valley. The joint effort has provided over 80 cords this past year.
  - Vice-Chairman Agapito Candelaria met with Brittany Ference, VISTA Intern, to discuss how the UCSWCD and CPLA collaborated on the Firewood for Senior Citizens program; a 2 minute video was posted on the CPLA website.














#### **Fire Prevention**

- Building Resiliency in the Upper Rio Chama Watershed Program, the District will....
  - Restore and build forest resiliency to deal with drought and catastrophic fires as the highest priority with adjacency as a key approach. The high fuel and drought conditions have posed a health and safety issue for residents within the district and downstream. Hazardous Fuel Reduction will minimize the flooding and erosion impacts during the intense storms, reduce the intensity of wildfire, and reduce the threat of catastrophic wildfires, and
  - Implement watershed rehabilitation to provide ecosystems benefits for livestock, wildlife, fisheries, acequias and erosion control. Taking a holistic approach toward watershed management will improve fish and wildlife habitat, water availability for wildlife and livestock, erosion control, and provide for the continuance of our cultural acequias.
- The District applied for in conjunction with Joe Carrillo, State Forestry, for the 2022 Hazardous
  Fuels Mitigation Projects in Wildland Urban Interface Areas (WUI) grant. We would have

served as the fiscal agent but we were not awarded any funding. The District will continue to apply in the future.

### **Education and Outreach**

- District Chairman Norman Vigil and Supervisor Eloy Olivas attended all CWMA meetings throughout the fiscal year. Upper Chama SWCD chairs the CWMA and East Rio Arriba SWCD is the fiscal agent.
- Sec/Treasurer Horace Leyba attended the monthly NMDA meetings held throughout out the fiscal year.
- Chairman Norman Vigil and District Forester Joe Carrillo participated in a **Water Trust Board** (**WTB**) meeting and met with their partner, the NM Forestry Division in October.
- Chairman Norman Vigil and Vice Chairman Agapito Candelaria attended the Rio Chama Congresso on April 29 at the Rural Event Center in Abiquiu. They made a presentation on our forest thinning projects and the collaborative efforts with NM State Forestry, Rio Chama Watershed Group, Chama Peak Land Alliance, Trout Unlimited and San Juan Rio Chama Watershed group.
- The District attended and participated in the **Team 3 Local Work Group** meeting in Abiquiu.
- Vice-Chairman Agapito Candelaria and Sec/Treasurer Horace Leyba are participating in the
  Resource Conservation and Development Council (RC&D) which is a program led by local
  volunteer councils that help people care for and protect their natural resources in way that
  improves the local economy, environment and living standards.
- Chairman Norman Vigil, Vice-Chairman Agapito Candelaria, and Sec/Treasurer Horace Leyba attended the Soil & Water Conservation Day at the Legislature in February.



- Vice-Chairman Agapito Candelaria met with Representative Joseph Sanchez about potential
  projects he is willing to assist the Upper Chama SWCD with and has extended his community
  assistance with our lobbying efforts for capital outlay for the upcoming legislative session.
- Chairman Norman Vigil met with **Senator Leo Jaramillo**, **Representative Susanna Herrera** and **Commissioner Moises Morales** about our awarded Capital Outlay funds.
- The District reached out to our local high school, Escalante High, to see if any students would be interested in attending the NM Youth Ranch Management Camp and we would pay their registration fee.

- The District hired a **part-time Conservation Technician** who will assist with the implementation of programs, equipment maintenance, landscape maintenance, snow plowing, equipment rental and other miscellaneous tasks.
- The District hired a **Contract Program Manager** to oversee the Building Resiliency in the Upper Rio Chama Watershed Program funded through SWCC.
